March: NON-REPRESENTATIONAL and ABSTRACT ART

Simply put, we're looking for art that is not realistic. I'm sure this will generate a lot of discussion, as it did last time, about what is non-representational and to what degree. It will be interesting to see how our thinking has evolved since the last time. All 2D and 3D art is eligible, including drawings, paintings, prints, sculpture, photography, digital works, mixed media, etc. This exhibit is not juried and the works do not have to be framed, only hangable with a wire in back. And please remember to sign your work.

The Wes DeVries Abstract Expressionism Workshop, which was held recently in our studio, introduced our participating artists to a unique process of creating non representational art. It was an adventure which lead most of us to a result that we could never have predicted. We'll be sharing our workshop paintings by displaying them together in one section of this exhibit.

Grand Valley Artists Juried Exhibition at Holland Area Arts Council

Located in beautiful downtown Holland, The Holland Area Arts Council will host a juried exhibit of the work of Grand Valley Artists in their Padnos and Armstrong Galleries, May 17 through July 6, 2019. HAAC is located at 150 E. 8th St, Holland, Michigan 49423.

The following guidelines have been established for this exhibit:

- •This exhibit of 80–90 works will be juried by Lee Ann Frame, BFA, MFA, Instructor of Art, Muskegon Community College.
- •HAAC will take 40% commission on art sales. All work must remain in the show until conclusion.
- •HAAC is a community, family friendly gallery. While nude images are allowed, do not submit sexually provocative images.
- •3D work including sculptures is permitted; large works (more than 60" or 100 lbs) need prior HAAC approval before submission. Check with Doug Klemm (616) 481-6121.
- •HAAC reserves the right to use the galleries during the GVA Exhibit. Some artwork may be temporarily moved.
- •GVA will hang the exhibit with oversight of HAAC staff.
- •The Opening Reception will be jointly hosted by GVA and HAAC.
- Awards: 1st Place \$400; 2nd Place \$300; 3rd Place \$200 and 4th Place \$100 will be selected by the juror and awarded at the opening reception.

APPLYING & SUBMITTING YOUR WORK

Submissions are open March 18 and close April 15, 2019. (No late entries will be accepted.)

Next, list your entries, numbering as follows:

- •Attach a photo of each entry.
- Your cost of entry is \$25 for one entry. Add \$5 for each additional entry.
- •Entries will not be considered complete until payment is received.

PRESENTATION OF WORK

It is to your advantage to submit clear crisp images of properly photographed work. Do not shoot your images through glass. Remove artwork from the frame before photographing. It is also best to crop the images so that only the art and not the matte or frame is photographed.

- •Work must be wired for hanging. Sawtooth hangers are not permitted.
- •Submit original art. No giclees or other reproductions of your art will be allowed.
- •Framing must show good craftsmanship.
- •No exposed glass edges
- •Entries will be handled with care. However, neither GVA nor HAAC is responsible for loss or damage to an artist's work. Selected images must remain for the duration of the show.
- •Please do not submit work that was previously shown in a show at HAAC.
- •If you have no computer access or have difficulty submitting your entries, contact Doug Klemm at (616) 481-6121.

- •Notification of Acceptance/Decline will be by email by May 3.

"At Eternity's Gate"—A film about Vincent van Gogh


This film was just released on DVD. It features such an intimate look at Van Gogh that it can be startling. The camera goes in so close, you can smell the air and the flowers, feel the dust, and have empathy for the pain in the

flawed person that was Van Gogh. Every painting shown on screen was created just for the movie, some even by the actor, Willem Defoe, as he stands in the fields of southern France, painting the ordinary workmen and women of the village and the idyllic landscapes around them. The whole movie moves slowly, hesitantly, as if you could hear the artist question what and how he is executing his someday masterpieces.


You want this painter to succeed, to change the way art is done and seen in a world not quite ready for that change. That will take years to happen, and when it does, Van Gogh will be gone. He wasn't able to see how groundbreaking his work was or to know how deeply loved he would become.

There is little joy in this movie, but it is still worthwhile. Vincent created 2,100 art works, including 860 oil paintings, most of which were painted during the last couple of years of his very short life.

The movie will inspire you to submit to our GVA April exhibit called the Van Gogh Challenge, which will hang April 1st and strike April 29th!

Is there value to entering your work in a juried

show?

Some folks feel that the value to entering juried shows lies in affirmation. When our work is accepted by a juror we feel validated; suddenly making art makes much more sense. Then there's the even better high of winning an award that distinguishes our work from that of our peers. But let's say you don't really see yourself as a competitor. Any reason to enter?

For me, the value in entering a show has less to do with the show and more to do with setting a bar for my own work. It takes courage to get my work out there, but once I make the leap I am able to focus on what I can do to make my paintings better. My goal is to build my skills, stretch myself, and learn to honestly judge my own artwork. Sometimes that means just looking at my own work as I would look at other work submitted to a show—from an objective viewpoint. As I prepare, I get feedback from other artists who help me see my work the way other artists or viewers might see it. Often subtle changes which I overlooked myself can lead to a much stronger piece. Succeeding helps build my confidence, but sometimes failing to get in helps me just as much because I learn new ways of looking at work and at the entire continuum from making to displaying. Continuing to enter shows helps me build a consistent portfolio and pushes me to keep my work current.

Beyond that, I like to support the arts community. Of course, there's always the off chance that a painting might sell, and that's all the affirmation I'll ever need!


