#### **Beginning Again**

"You are what you eat" and "What is in the heart, comes out of the mouth." I believe the emotional and spiritual state of the heart, soul and mind can be expressed on a canvas with the handling of the choice of the subject, color value, and style of execution.

I was asked to briefly write down what I verbalized at Critique night last Thursday. It was an emotional moment for me when I exposed a bit of my past to the group and the struggles that I had with life and the effect those difficulties had on my ability or inability to paint. I knew I had some talent, but it fell by the wayside for many years.

Several years ago I became involved with GVA to be inspired to paint again. I don't believe I would have grown as an artist without the encouragement and support of this great group of people who reached out to me in my need. They believed in me when it was hard to believe in myself, and helped bring back some self confidence. However, a couple of years later, my life took a real downturn and I quit attending GVA meetings for a few years. I didn't paint much. I was just trying to mend the broken fragments of my life and try to heal.

Five years ago I was remarried to a wonderful man, Dale, who gives me joy in life. He loves to see me paint and he challenged me to rejoin GVA and get the support from the other artists. It was precisely what I needed; renewing the friendships. I have been delighted with my growing progress as an artist as well as a person.

Two weeks ago, I did something drastic to several past artworks that I believe will shape my painting ability and my outlook on life for good. I burned them. There is no turning back. In the process of building my new art studio in our home, I had to sort through several art pieces that I had not viewed for years. Some of them were fairly good, others plain ugly. Many brought great emotional pain reflecting my past. I wasn't ready for the surge of emotional pain in reliving the past, but in the process I knew that I had to CHANGE something. I did not want my new growing experience to be stunted by my emotional baggage from seeing these paintings.

Choosing to burn paintings that I had saved for a long time made me feel like I was cutting off my arm.

But there is beauty from the ashes. I was surprised how quickly God and Dale helped me recover. My new found freedom has allowed me to "see" the beauty in God's world and everyone in it with new eyes and a compassionate heart. I even went a step further and destroyed hurtful written memories that were tucked away in an attic corner. It was a total cleansing process with a mindset of never revisiting the pain of that past again.

I hope this letter will encourage those who identify with it, and may not have ever voiced your own past or present pain; much less given it thought that the emotion has affected the way you paint. Art is an inside emotion expressed outwardly on canvas for others to interpret. Do you know what you are communicating?

Enjoy God's gift of life to the fullest. "But they that wait upon the LORD shall renew their strength; they shall mount up with wings as eagles; they shall run and not be weary, and they shall walk and not faint." Isaiah 40: 39.

# My Adventure at the Alten Exhibit! Sarabeth Carr

After misreading information in a recent Press article about the opening of the 2nd floor gallery, an expansion of the Gordon Gallery in the DeVos Center at GVSU, I went downtown on Thursday in November to view the Mathias Alten exhibit. Just finding a parking place had me jumping thru hoops as I found out I needed to get a visitor pass at the Eberhard Center to then proceed to the Devos Center parking lot. (Warning-the Engineering School now takes up most of the erstwhile Eberhard Center parking lot!) There were no spaces available at the DeVos lot except a visitor parking meter. I had change for 45 minutes so headed over to what I hoped was the main entrance to the complex of buildings. A kind staff member aimed me in the right direction.

The doors to the Gallery were open so I entered the first room and noticed several people sitting around a table in the second room. As I strolled the gallery enjoying this wonderful exhibit, a staff member approached and said the room was going to be closed in 5 minutes for a private lunch.

But I could view the upstairs room if I would wait for another staff member to get the key.

Upstairs we went and I had rooms to myself for the duration of my visit. There are about 40 new pieces on loan from the Gordons, including quite a few scenes of Grand Rapids environs.

How fortunate we are to have this fabulous collection in our town! When I told the staff person about my parking woes and wouldn't it be great to have the exhibit more accessible, she concurred, telling me that GVSU is well aware of the problem and is on the lookout for more space. What surprised me was that GVSU was the only entity interested in having the collection in the first place.

It is well worth your while to visit this exhibit of one of Grand Rapids' most prominent artists.

Do visit on a Friday or Saturday afternoon when the exhibit is actually open, and when parking will probably not be an issue.
